The following recommendations were noted : 1) Segregation of Duties 2) Changes in data entry and reports through the automated data system 3) checks should have two signatures 4) condition of a defendants sentence should not include payment of fines, costs or incarceration 5) Court Software should be modified to: require verification of needed information for dismissals; an
create an automated record that has controls to assure jail terms as set by statute are met; create controls that test judgment orders for statutory conflicts; include controls that automatically cause a misdemeanor case to be activated

once the 10 day notice period has expired; be automated to report all unpaid costs to the tax commissioner and modified to automatically generate a register of unsatisfied judgments. **6)** Court should obtain Prosecuting Attorney approval on all plea agreements prior to acceptance by the court **7)** Citations should be signed or initialed by the magistrate that the defendant was advised of their constitutional rights **8)** all dismissed cases should contain a form stating the request for dismissal was made by the Prosecuting Attorney and accepted by the magistrate.
