Sgt. Cayton presents the Fiscal year 2015-16 Prevention Resource Officer Grant funding Application. The Lewis County Commission and Lewis County Board of Education have collaborated for many years to have Prevention Resource Officers in Lewis County High School and Robert L. Bland Middle School. The FY 2015-16 grant will provide \$28,000.00 (project maximum) for the Prevention Resource Officer at Lewis County High School. The request is submitted to the Lewis County Commission and Lewis County Board of Education to provide the additional funding for the High School Officer and a collaborative agreement to fund the Prevention Resource Officer at Robert L Bland Middle School. Both officers will work as Prevention Resource Officers for 10 months. The balance not covered by the grant for both officers is: Lewis County Commission \$53,268.11; Lewis County Board of Education \$ 38,048.65. The difference is that both entities split the cost of both officers for 10 months and the Lewis County Commission pays 100% of the salaries for 2 months minus the \$28,000.00 grant award for the High School Officer.
