WHEREAS, the said will further named Thomas C. Davisson as Executor thereof; and

WHEREAS, the said Thomas C. Davisson appeared and filed a waiver to qualify as such Executor and waiver of other siblings to qualify as Administrator c.t.a. of the will of Richard Joseph Cronin, deceased, and requested that Benjamin G. Davisson be appointed as Administrator c.t.a. of their said decedent.

THEREUPON, personally appeared the said Benjamin G. Davisson together with Westfield Insurance Company as his surety and entered into and acknowledged a bond in the penalty of Two Hundred Thousand Dollars (\$200,000.00), payable to the state of West Virginia conditioned according to law, which bond is hereby approved and deemed sufficient. And, thereupon, the said Benjamin G. Davisson qualified as Administrator c.t.a. of the personal estate of Richard Joseph Cronin, deceased, by taking the oath subscribed by law.

It is stated by said Administrator c.t.a that Richard Joseph Cronin departed this life on the 29th day of May, 2014, aged eighty-seven years.
