IN RE: APPROVAL LOMBARDI CONSTRUCTION FOR RENOVATIONS FOR THE LEWIS COUNTY ASSESSORS OFFICE

On January 12, 2015, after being duly advertised as per WV Code, the bids for the Lewis County Assessor's office were opened and inspected for compliance by Fred Pack, Project Consultant for Silling Associates. All bids were over budget and on motion and second it was tabled for further review with the assessor and the architect. At the January 20, 2015 meeting, Lombardi Development, Fallensby, WV was acknowledged as apparent low bidder at \$593,500.00 base bid. Today, Assessor T. Chad Kelley appeared before the commission with the recommendation to accept the bid from Lombardi with the following reductions: 1. General Conditions Savings \$9,500 (Bond, B&(, Port-a-Jon, etc.) 2. Buy Direct Savings \$7,000.00 (HVAC, Electric, Metals, Casework, Doors) 3. HVAC \$5,000.00 (Carrier in lieu of specified manufacturer) 4. Electric \$1,500.00 (Plastic exit signs in lieu of specified) 5. Delete all painting from contract \$10,000.00 6. Signage \$2,000.00 (4 pcs only, not as specified) Total Savings \$35,000.00. New bid total \$558,500.00. On motion of Patrick D. Boyle, second by Thomas V. Fealy, vote unanimous to accept the bid of \$558,500.00 and award the project to Lombardi Construction.

IN RE: MINUTES, INVITATIONS, NOTIFICATIONS, CORRESPONDENCE

- 1. **Upshur County Commission Agenda** The Upshur County Agenda for Thursday, February 19, 2015 was received.
- 2. **Sheriff's Monthly Vehicle Report** The Sheriff's Monthly Vehicle Report including mileage and maintenance for the fleet in January, 2015 was filed.
- 3. Louis Bennett Public Library Minutes/Financial Report The meeting minutes and financial reports for October, November, and December, 2015 and January, 2015 including expenditures from hotel/motel taxes received from the county was received. County Administrator Cindy Whetsell pointed out to the commission that some of the expenditures of the hotel/motel tax were not allowed by WV Code. Commission directed Ms. Whetsell to set up a meeting with the three recipients of the hotel/motel tax (Lewis County Park, Town of Jane Lew for Jane Lew Park and Louis Bennett Library) to discuss the allowable expenditures.
- 4. **Lewis County Animal Control Monthly Report** The Lewis County Animal Control report for January, 2015 including the number of animals picked up, dropped at facility, adopted, bounty collections, and animal control vehicle mileage was filed. Commission asked County Administrator Cindy Whetsell to request an explanation of why an animal other than cat and dogs was picked up.
- 5. Lewis Upshur Animal Control Facility Monthly Report The January, 2015 monthly report for the Lewis Upshur Animal Control Facility including number of dogs and cats housed at the facility, number of adoptions, number of animals returned to owners and number of animals brought in to the shelter by staff and citizens for both Lewis and Upshur Counties.
- 6. **Sheriff's Monthly Settlement** The January sheriff's monthly settlement (reconciliation) of the accounts for January, 2015 for Lewis County was submitted by Sheriff Adam Gissy.
- 7. WV State Department of Revenue Statewide Computer Cost Estimate Notice was received from the WV Department of Revenue, State Tax Department for the budget amount for the fiscal year 2015-2016 for the Statewide Computer Network, Account #408 \$49,762.00. Assessor T. Chad Kelley reported this was an increase over prior year and requested the commission send a letter requesting an explanation of the increase. On motion of Thomas V. Fealy, second by Patrick D. Boyle, vote unanimous to approve sending the letter.
- 8. Lewis County Senior Center Board Letter of Appreciation The Lewis County Senior Center Board sent a letter expressing their appreciation to the Commission for their contribution on the roof repair.

Commissioners Thomas V. Fealy, Patrick D. Boyle and President Agnes G. Queen attended the Lewis County Board of Equalization and Review, Friday, preparation of ballot boxes, and Saturday, Election Day for the Lewis County Board of Education Levy.

President Agnes G. Queen attended the WVU Extension Service meeting on annual funding. County Administrator attended the conference calls with the CCWVA on legislative issues.

IN RE: APPROVAL OF PURCHASE OF BLOCK OF 50 MAILBOX LICENSE

County Administrator explained to the commission the need to purchase a block of 50 voice mailboxes for the telephone service. This is a onetime cost. The commissions purchased 150 voice mails with the new telephone service and have used 146. For further expansion we will need more voice mail boxes. Each voice mail box corresponds to a telephone extension and we cannot add extensions without the voice mail box. On motion of Patrick D. Boyle, second by Thomas V. Fealy, vote unanimous to approve the purchase from Frontier at a cost of \$930.00.


