Commissioners, Keith Talbert and I have went over the three (3) proposed radio RFP's. We have determined that all solutions would work for the 911 center and appear to meet the requirements set forth in the RFP. I have broken down the results and have them listed below.

1. Lauttamus Communications- bid a Avtec radio solution
